It is simple! You pick up a reloadable gift card from Cathy, put any amount onto it (up to \$250) in any Kroger store and then shop with it like you would with a gift card. 4% of the total dollar amount loaded on the card comes back to the Club, your skater will receive 50% of your card's total earnings!
