Minutes

The minutes of the 8/20/08 board meeting were accepted.

Treasurer's Report

Checking balance is \$25,843.41; savings \$3,536.29 (includes Kroger check for \$228.00 from 9/5); SSS fund \$1,650.16; credit card balance is \$119.18; outstanding receivables are \$65,261.82.

We are in the process of hiring the CPA firm *Hoover & Roberts* (Eaton) to do our tax documents which must be filed by 11/15 (annually). We will file an extension to 2/15. Estimated costs will be \$700-\$1,000 each year.

The Board accepted the treasurer's report.
